By selecting the content level that best fits your business needs and comfort level, you can confidently engage with your audience while ensuring that your posts align with both platform requirements and the content that your customers are used to seeing from your account.

Creating your own posts

We get it, consumption is personal! If you prefer to speak to your own cannabis experiences and why it's important to only buy from licensed retailers, then please follow a few do's and don'ts. After all, Real CA Cannabis is a state educational

campaign, so naturally there are a couple guidelines that we encourage all campaign supporters to follow.

Do's

- Be sensitive: Everyone experiences cannabis differently and utilizes it for various reasons. Please only speak to your own personal experiences using cannabis.
- Inform your followers! Share why it is important to purchase cannabis from a licensed, legal retailer educating consumers is the purpose of Real California Cannabis!

Don'ts

- Don't include minors (anyone under 21) or pets.
- Don't use language that contains any health-related statement that is untrue in any particular manner or tends to create a misleading impression as to the health effects of cannabis consumption.
- Don't post content that displays nudity or undergarments.
- Don't use offensive or profane language.
